Antidumping duty and countervailing duty (ADD/CVD) compliance is a Priority Trade Issue for CBP. Importers are often hit with unexpected retroactive assessments, and in some case penalties, for errors in clearing ADD/CVD merchandise. CBP and ICE continue to conduct extensive investigations of suspected ADD/CVD evasion. This webinar will explain the ADD/CVD process in simple terms that will allow importers, shippers, and brokers to effectively communicate as well as address common compliance concerns surrounding the processing of ADD/CVD entries for both the customs brokers processing the entries, and their importer clients.
