The ins and outs of ATA Carnets



Course Description:

The FTA is happy to present a timely webinar about ATA Carnets. An ATA Carnet is an international customs document that provides duty-free customs clearance for temporary exports into over 100 countries. ATA Carnets simplify these temporary exports by eliminating the need to post a temporary import bond or pay the import duties and taxes to enter a foreign country. Virtually all goods, whether hand carried or cargo-shipped, may be covered by ATA Carnets. Highlights of this webinar include: ATA Carnet best practices, proper customs clearance procedures, managing inevitable breaches and extensions on ATA Carnet exports.

Amanda Barlow is the Vice President of ATA Carnet for Roanoke Insurance Group. Primarily the Lost Document Coverage and ATA Carnet Cargo Insurance programs. She is a licensed insurance broker in the state of California and holds a non-resident insurance brokers license in the state Illinois.

Ms. Barlow regularly presents on behalf of Roanoke for a wide variety of associations, department of commerce, and trade groups' educational events, seminars and webinars. In addition, Ms. Barlow is tasked with training U.S. Customs and Border Protection on the accurate use and smooth processing of both U.S. and Foreign ATA Carnets.

Ms. Barlow authored and taught for several semesters the Export Promotion Marketing course for the international trade and marketing department at the State University of New York's Fashion Institute of Technology (FIT-SUNY), where she has been an Adjunct professor since 2006. She also sits on FIT-SUNY's Gemini Shippers Association's Scholarship Committee, as well as their International Industry Advisory Board, which ensures that the curriculum is continually in line with industry advancements.

Ms. Barlow is a member of the National Customs Brokers and Freight Forwarders Association of America's Educational Institute (NCBFAA-EI) Marketing Subcommittee, along with representing Roanoke and our clients in the Trade Support Network (TSN) and USCIB's Customs and Trade Facilitation Committee. She served as the Secretary and Marketing Chair on the Organization of Women in International Trade New York chapter's board of directors from 2009 until 2012, where she is still an active member.

Prior to joining Roanoke, Ms. Barlow was the Marketing Director in the Carnet and Trade Services Department of the U.S. Council for International Business' (USCIB). She was responsible for the marketing, promotion and development of USCIB's Trades Services. She joined USCIB in 2005 as an entry level ATA Carnet issuing representative, and moved very quickly into management. Before joining the USCIB, Ms. Barlow worked with ATA Carnets for a New York based Italian fashion house.
