A Hong Kong newspaper owner was [sentenced to fourteen months in prison](#) today for his role in 2019 protests, along with several others who have been barred from running for seats in the government.

The US State Department under Secretary Blinken has taken a vocal role in denouncing actions like this and undoubtedly will continue in this case and others.

## Government Actions and Trade

### **U.K. Businesses Burn Cash as Brexit Bureaucracy Takes Its Toll**

Breaking free of Brussels bureaucracy was meant to herald a bonfire of red tape for Britain. In the first 100 days of Brexit, the only thing many businesses burned was money.

### **China's Growth Set to Drive World Economy in Post-Pandemic Years**

China will contribute more than one-fifth of the total increase in the world's gross domestic product in the five years through 2026, according to Bloomberg calculations based on IMF forecasts published Tuesday.

### **The Case for a Transit-First Infrastructure Plan**

President Biden's \$2 trillion jobs plan would double the federal contribution to public transit. But to fight climate change and broaden access to opportunity, that won't be enough.

President Biden on Thursday announced retaliatory measures against Russia over election interference, the SolarWinds cyberattack and other malign activity, saying he isn't seeking to kick off "a cycle of escalation" but would take more drastic action if necessary.

### **CBP Air and Marine Operations and Partners Seize Combined 4 Tons of Cocaine in Eastern Pacific**

Between February 27 and March 22, U.S. Customs and Border Protection (CBP) Air and Marine Operations (AMO) P-3 aircrews of the National Air Security Operations Centers (NASOC) partnered with federal and international authorities to disrupt four smuggling attempts in the Eastern Pacific Ocean and seized a combined four tons of cocaine, denying narcotics traffickers approximately \$152 million in illicit proceeds.

CBP's recent emphasis on forced labor violations is driven by a sense of social responsibility, and is mandated by Section 307 of the Tariff Act of 1930 (19 U.S.C. § 1307), which prohibits the importation of merchandise mined, produced or manufactured, wholly or in part, in any foreign country by forced or indentured child labor – including forced child labor. Such merchandise is subject to exclusion and/or seizure, and may lead to penalties and criminal investigation of the importer. The social injustice of forced labor when coupled with the risk of substantial penalties and the loss of import privileges, makes a Forced Labor policy an integral part of any robust import compliance program. 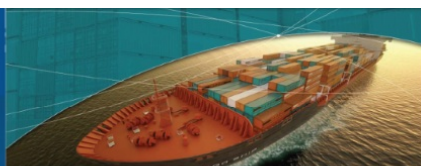

### **March Madness at POLA**

Port of Los Angeles Executive Director Gene Seroka announced cargo volume was 957,599 Twenty-Foot Equivalent Units (TEUs) in March 2021, a 113% leap compared to March 2020 when global trade slowed to a crawl at the outset of the COVID-19 pandemic. It was the strongest March in the Port's 114-year history, its busiest first quarter, and by far the largest monthly year-over-year increase.



## Logistics and Trade

The Port of Los Angeles processed 957,599 Twenty-Foot Equivalent Units (TEUs) last month for a 113% leap compared to March 2020 when global trade slowed to a crawl at the outset of the COVID-19 pandemic.

### **LaserShip, OnTrac Top List of Fastest-Growing 'Trucking' Firms**

Four parcel carriers were among the five fastest-growing trucking companies in 2020, thanks to a 44 percent increase in e-commerce spending, SJ Consulting Group data shows.

Stakeholders fear a new COVID-19 lockdown that has gone into effect in Bangladesh will worsen congestion at the Chittagong port yard, further slowing the delivery of containers.
