The Foreign Trade Association joined over 75 other international trade organizations encouraging California State legislation on responsible demurrage and detention charges. OSRA 21 Coalition Update

The Advocacy Committee of the FTA has been working in collaboration with the other national and local trade associations seeking passage of the Ocean Shipping Reform Act of 2021. On Dec. 8, 2021, under <u>House of Representatives Suspension Rules</u>, (which allow non-controversial bills to be voted on quickly), the House passed <u>HR 4996</u> by a vote of 364 to 60. Now the Senate is working on a companion bill and despite the momentum gained, adoption in the Senate will be a challenge. As a Senate bill is introduced we will provide the details.

Can Crypto Replace US Dollar for international Trade? Industry Experts Weigh In

It is a matter of debate whether a cryptocurrency will replace US dollar for international transactions in the coming years. However, Rajnish Kumar, chairman, BharatPe and former chairman SBI believes crypto is the buzzword of the new age economy and it is not defined by national boundaries.

U.S. Renews Tariff Exemptions for Some Chinese Imports

The Biden administration conducted a review of 549 categories of goods for which waivers were sought, and on Wednesday the U.S. Trade Representative's office said it had granted 352 exclusions while denying the rest Wednesday's decision will have a relatively small impact on the tariffs overall. The tariffs imposed in 2018 and 2019 covered more than \$350 billion a year worth of trade, and companies had filed more than 53,000 requests for tariff relief.

As Inflation Surges, Biden Targets Ocean Shipping

Daniel B. Maffei, the chair of the Federal Maritime Commission, said in an interview that there was "no question" that changes in consumer demand as a result of Covid had driven a rapid increase in shipping prices. But, he added, "does that mean the carriers have to charge this much?" The commission has never filed an antitrust case against a carrier. But Mr. Maffei noted that "conditions are absolutely, totally different now than they were two years ago. The pandemic has changed everything."

Quad Trade Ties Grow Despite Tensions Over Russia

Australia and Japan announced a flurry of new investments in India in recent days. The three countries, along with the U.S., are part of a group of democratic countries called the Quadrilateral Security Dialogue, also known as the Quad.

Russia Allegedly Seizes Ships Carrying Ukrainian Grain

Ukrainian prosecutors have opened an investigation into the alleged forceful seizure by Russian troops of five ships carrying Ukrainian grain in the port of Berdiansk, the general prosecutor's office said on Monday. India has diverged with the group's other countries over Russia's invasion of Ukraine, as New Delhi has avoided directly condemning Moscow. While the other countries

have urged India to take a tougher stand, they haven't allowed their differences on the invasion to get in the way of their growing security and economic ties.

USTR Extends 352 Expired Exclusions from Section 301 Tariffs on China

The U.S. Trade Representative on March 23 announced the extension of 352 exclusions from Section 301 tariffs on China. The exclusions, all of which had expired, resume effect as of Oct. 12, 2021, and will remain in effect through Dec. 31, 2022, USTR said. The exclusions include 89 covered under List 1 Section 301 tariffs, 34 under List 2, 187 on List 3 and 42 exclusions covered by List 4, according to a pre-publication notice released by USTR. Most had expired at the end of 2020, but some expired in 2021.

Germany Calls for New Talks on Transatlantic Trade Deal

Germany's finance minister has called for fresh talks over a free trade agreement between the European Union and the United States, a newspaper reported on Sunday, aiming to revive discussions halted by former U.S. President Donald Trump.

Ship Departures from Russian Ports Fall by a Third; Grain, Coal Shipments Down 72%

"It's a big fall and it will get worse," a Singapore-based dry-bulk broker said. "The Black Sea is riddled with mines and it's out of bounds. Moving Russian or Ukrainian exports is expensive and very risky." Lloyds List said the number of China-bound bulk carriers has halved since the Russian invasion last month.

U.S., U.K. Strike Trade Deal to End Tariffs on British Steel and American Whiskey

Biden administration officials said the agreement with the U.K. will allow the U.K to ship "historically-based sustainable volumes" of steel and aluminum products to the U.S. without levies imposed under the former Trump administration. In exchange, the U.K. will lift retaliatory tariffs on more than \$500 million worth of U.S. exports to the U.K., including distilled spirits, farm products and consumer goods.

Magnus Looks Ahead | U.S. Customs and Border Protection

Sitting down with U.S. Customs and Border Protection Commissioner Chris Magnus to discuss his first 100 days at the helm of the nation's largest federal law enforcement agency, the conversation quickly focused on the importance of working with people to get things done. "Everything I feel has been a successful accomplishment has been the result of a team that I've been part of."

Pressed to Choose Sides on Ukraine, China Trade Favors the West

Despite growing trade ties to Southeast Asia and an economy that is less dependent on trade over the past decade, China's economic interests remain heavily skewed to Western democracies, trade data reviewed by Reuters showed. Siding with political ally Russia would make little economic sense for China, according to analysts, as the United States and European Union still consume more than a third of China's exports.

<u>China Must Engage Australia to Boost CPTPP Chances, Trade Minister</u> <u>Says</u>

The trade bloc, which emerged in 2018 from the ashes of a previous trans-Pacific pact that fell apart following the US' withdrawal, counts Australia, Singapore, Vietnam, Japan, Canada, Mexico and Peru among its members – and represents some US\$13.5 trillion in combined gross domestic product.

U.S., U.K. Reach Deal to Ease Tariffs on Steel and Aluminum

The deal will allow 500,000 metric tons of steel annually to be imported duty free, with higher amounts subject to tariffs, starting June 1, the Commerce Department said in a statement. The U.K. also will end retaliatory tariffs on more than \$500 million worth of U.S. exports, including distilled spirits, agriculture products and consumer goods.

SECTION 301 UPDATE

U.S. TRADE REPRESENTATIVE REINSTATES 301 EXCLUSIONS

After 5 months of consideration the U.S. Trade Representative ("USTR) released a list of products that would once again be subject for an exclusion from Section 301 duties until December 31, 2022. On March 23, 2022, the USTR reinstated 352 previously extended exclusions. Qualifying products can claim the exclusion immediately, and the exclusions are retroactive to any products entered for consumption, or withdrawn from warehouse for consumption, on or after 12:01 a.m. eastern daylight time on October 12, 2021, that are not liquidated or to entries that are liquidated, but within the period for protest described in section 514 of the Tariff Act of 1930, as amended. 

Is Jet Fuel From Waste Finally Ready for Takeoff?

Fulcrum is one of several companies lining up to produce SAFs as the global air industry looks for more environmentally preferable alternatives to conventional jet fuel. International air transportation accounts for 65% of aviation fuel use globally, and aviation CO2 emissions are projected to increase to between 1.1 billion and 1.5 billion metric tons by 2035, according to the International Civil Aviation Organization. Late last year, in recognition of this trend, the United Nations set criteria for SAFs.

Climate Change Is Disrupting the Global Supply Chain Too

The pandemic is "a temporary problem," while climate change is "long-term dire," said Austin Becker, a maritime infrastructure resilience scholar at the University of Rhode Island. "Climate change is a slow-moving crisis that is going to last a very, very long time, and it's going to require some fundamental

changes," said Becker. "Every coastal community, every coastal transportation network is going to face some risks from this, and we're not going to have nearly enough resources to make all the investments that are required."

Port of New Bedford to Open Terminal to Support Offshore Wind

The new terminal will provide storage and laydown yards for equipment and materials, berth facilities for tug and barge operations, and crew transfer vessel (CTV) and service operation vessel (SOV) support services. It will also offer new office space for project teams and a marine coordination centre for technicians involved in offshore wind projects.

How Can Short Sea Shipping Emissions be Reduced?

The maritime transport of freights and passengers conducted along coastlines, without crossing oceans, is a commonly used definition for short sea shipping (SSS). In Europe, SSS has been the traditional mode of transport for centuries, used for moving goods and/or people from one port to another.

Five Key Takeaways From SEC's Proposal for Climate Disclosures


The U.S. Securities and Exchange Commission issued a 500-plus-page proposed rule Monday that would mandate corporate disclosure of greenhouse gas emissions. It builds on years of voluntary efforts. With publicly traded companies responsible for 40% of emissions, investors have been pressing the regulator for rules. The plan is "the most extensive, comprehensive and complicated disclosure initiative in decades," said Meredith Cross, a former SEC director who's now a partner at law firm WilmerHale.

Ukraine Says All Its Ports Remain Closed To Ship

All Ukrainian its ports on the Black Sea and Azov Sea remain temporarily closed to ships seeking to enter or exit, Ukraine's infrastructure ministry said on Monday. Soon after Russia's invasion on Feb. 24, Ukraine's military suspended commercial shipping at its ports, stoking fear of supply disruption from leading grain and oilseeds exporters.

Ocean Carriers' U.S. Export Services Face Greater Scrutiny Under New FMC Directive

Since its launch, the VOCC Audit Program has collected information on detention and demurrage policies from the nine largest ocean carriers by market share, provided briefings to ocean carriers on the FMC rule interpreting 46 USC 41102(c) as it applies to detention and demurrage practices, communicated best practices with ocean carriers, and continues to receive quarterly data on detention and demurrage metrics.

Why Russia-Ukraine War Has Not Ignited Crude Tanker Rates (yet)

Wars involving oil producers traditionally cause tanker rates to spike. A month into the Russia-Ukraine war, rates for most crude tankers remain abysmally low. Rates for product tanker rates are up but not exceptionally high. "The immediate knee-jerk reaction was: Disruptions create strength in the market," said Evercore ISI analyst Jon Chappell. "We saw that in 1991 and we saw that in 2003, so the thinking was: Here we have another geopolitical event that's going to lead to [oil] storage and the substitution effect [buyers finding news sources]."

Chinese Port Congestion Worsens

Shenzhen came out of a seven-day lockdown yesterday, and while its port workers were allowed to work for the duration of the shutdown, limited trucking and warehousing availability has created some supply chain issues. An update from Danish liner Maersk yesterday forecast vessel waiting times will increase in Shenzhen. Elsewhere, Covid flare-ups are causing port pressures at key gateways including Qingdao, Shanghai and Ningbo-Zhoushan.

<u>Viewpoint: It's a tangled game of Twister for drayage in China – Supply</u> <u>Chain Council of European Union</u>

Drayage is a forward-looking indicator on the impact of "zero COVID" in the movement of trade in China. People are needed to drive the trucks. Roads must be open to reach factories and warehouses — which, of course, must also be open. The drayage component of trade is essential, especially to ensure the fluid transportation of empty and full containers.

Four Shippers Under Investigation by Coast Guard at Port of LA

At approximately 8:20 p.m. PST on March 4, watchstanders at Coast Guard Sector Los Angeles-Long Beach received a report of a shipping container on fire. The container was due to be loaded on a vessel sailing for China on March 10. The Los Angeles Fire Department extinguished the fire. However, those efforts were complicated because the container was not marked as carrying hazardous materials. The bill of lading for the container indicated that it was carrying "synthetic resins." Further investigation revealed that it actually held about 18,000 pounds of used lithium-ion batteries, which are a regulated hazardous material.

East vs. West: McCown Report Highlights Continued Gains for East Coast Container Ports

Noted names like and Maersk and Sea-Intelligence (closely tied to the Maersk organization) have hinted that "things will get back to normal" later in the year, with the latter suggesting that overall "reliability "(think about adherence to schedules) is presently down to low levels, circa 30%, not seen in more than a decade.

The Ever Given Grounding one Year On

"Never in the field of global shipping has one ship ever given so much entertainment and laughs. The grounding of the ultra-large container ship made a splash in global news and drew an equally big response online as people rushed to their meme-making apps and cracked open a smile," wrote Steven Jones from the Propeller Club Liverpool one week on from the grounding last year.

Meanwhile, China's private processors are still thought to be targeting their favored cargoes from the east of Russia -likely at knock-down prices.

Canadian Pacific Railway Work Stoppage Ends with Agreement to Enter Into Binding Arbitration

Union members are to return to work on Tuesday at noon local time. CP said it will immediately begin working with customers to resume normal train operations across Canada as quickly as possible. Wages and pensions remain stumbling blocks, said the union in a statement.

Food Supplies Running Low On Foreign Ships Stuck In

Food and medical supplies onboard over 100 foreign flagged ships stuck in Ukraine due to the conflict are running low, with little progress on creating a maritime corridor to allow them to sail away, industry officials said on Wednesday.
